These are the travel conditions for International Leisure Travel, Inc., hereinafter

required to secure a reservation on this tour. **NO RESERVATIONS ARE ACCEPTED**
WITHOUT A DEPOSIT and signed reservation coupon. Full payment is required as
indicated in the brochure. \$25 Return Check Fee.

CANCELLATIONS: All cancellations **MUST BE IN WRITING & SIGNED to be**
valid. Cancellations received 71 days or more prior to departure are levied a \$35 per
person fee. **70-51** days prior to departure cancellation fee is 25% of tour cost. **50-31**
days prior to departure, cancellation fee is 50% of tour costs. **WITHIN 30 DAYS OF**
DEPARTURE THERE IS NO REFUND. NOTE: Cancellations apply to all participants;
family emergencies or health difficulties do not alleviate cancellation fees.
Reservations may be canceled for non-payment. **Reinstatement Fee is \$50pp**, if
space is available. **(Verbal or email cancellations NOT accepted.)**
